

Gloves, Ground, 55 Cal, Kevlar-Lined, Leather, Rainproof, Insulated



1. Scope

This standard covers the requirements for insulated, rainproof, leather, Kevlar-lined, 55 cal ground gloves.

This standard applies to the following Seattle City Light (SCL) stock numbers.

2. Application

Insulated, rainproof, leather, Kevlar-Lined, 55 cal round gloves are intended for use in freezing and snowy weather.

These gloves also provide excellent dexterity as well as cut resistance and FR protection.

Ground gloves are not appropriate for use as protectors over insulating rubber gloves or for any sort of protection against shock or hazardous voltage.



4. Requirements

Gloves shall be composed of the following:

- An FR cowhide leather outer shell, tanned for oil and water resistance
 - Nomex insulation
 - 100% waterproof membrane
 - Cut-resistant Kevlar lining
 - Arc flash rating: FR55 (55 cal/cm²).
 - Puncture resistance rating: Level 5 (ANSI/ISEA)
 - Cut resistance rating: Level A4 (ANSI/ISEA)

5. Packaging

Each standard package shall be legibly marked with the following information:

- Manufacturer identification
- Product description and size
- SCL stock number

Each shipping container shall be legibly marked with the following information:

- Manufacturer identification
 - SCL purchase order number
