2. Application

Hip high rubber boots are primarily used by personnel in general industrial, farm, and occupational applications where waterproof footwear are needed.

Boots identified in this standard are steel safety toe and shank boots.

Hip boots shall meet the applicable requirements of the following industry standards:

ANSI Z41-1999; Protective Footwear (Formally Withdrawn a)

ASTM F 2412-11; Test Methods for Foot Protection

ASTM F 2413-11; Specification for Performance Requirements for Protective Footwear

OSHA 1910.136; Foot Protection

Note:

^a ANSI Z41 1999 standard has been formally withdrawn and replaced with ASTM F 2412-11 and ASTM F 2413-11. Manufacturers citing ANSI Z41 should be corrected to reflect the latest ASTM protective footwear standard.

4. Requirements

Hip boots shall be constructed as follows:

- Rubber, seamless, and 100% waterproof
- Hip high, over-the-sock, pull-on style
- Adjustable with buckle closure for secure fit
- Belt loop strap
- Treaded outsole to prevent slips and falls
- Steel toe and shank per ASTM F 2412-11 and ASTM F 2413-11
- OSHA 1910.136 compliant

All new protective footwear, not including those already in inventory, shall meet the latest protective footwear standards.

Seattle City Light Material Control personnel may identify and approve manufacturers.

5. Packaging

Each standard package shall be legibly marked with the following information:

- Manufacturer identification
- Product description
- SCL stock number
- Quantity contained

Each shipping container shall be legibly marked with the following information:

- Manufacturer identification
- Product description
- SCL purchase order number
- SCL stock number
