

First Aid Kits, General-Use

1. Scope

This standard covers the requirements for general-use first aid kits and replenishment supplies.

This standard applies to the Seattle City Light (SCL) stock numbers cited in Section 8.

Supplemental first aid supplies (see SCL 4018.15) are supplies not normally included in general-use kits.

Trauma first aid kits and replenishment supplies are specified in SCL 4018.29.

First aid kit cabinets installed on the walls of SCL facilities are stocked by third-party contractors. Contact Safety Health and Wellness (SHaW) with requests for restocking.

2. Application

16-unit kits are designed for use in small offices and vehicles intended to serve up to 12 persons.

24-unit kits are designed for use in offices, vehicles, and small work sites intended to serve up to 15 persons.

36-unit kits are designed for use in offices, vehicles, and construction work sites, intended to serve up to 24 persons.

3. Industry Standards

First aid kits shall meet the applicable requirement of the latest revision of the following industry standards:

ANSI Z308.1; Minimum Requirements for Workplace First Aid Kits

OSHA 1910.266; App A - First Aid Kits

4. Requirements

First aid kits shall have unitized contents and quantities as shown in Section 8. See Figure 4 for kit example.

Replenishment supplies shall be shrink-wrapped in individual boxes (unitized).

Stock numbers 110121 and 110123 shall be ANSI Class A - Type III compliant.

Stock No. 110124 shall be ANSI Class A – Type III and OSHA 1910.266 compliant.

First aid kit cases shall have the following attributes:

- Steel hinged metal
- Water resistant
- Gasket lid
- Carrying handles
- Physical dimensions as shown in Table 4.
- Seattle City Light First Aid Kit label (see Figure 4b):
 - Imprint Color: Pantone Matching System (PMS) 293C (Cyan Blue) with black lettering
 - Label size: 80% of total kit surface area, centered

5. Marking

First aid kits shall have a content and quantity label on the inside of the case lids.

6. Packaging

First aid kits shall be packaged to prevent damage during shipping, handling, and inside storage.

Each standard package shall be legibly marked with the following information:

- Manufacturer identification
- Product description
- SCL stock number
- Quantity contained

Each shipping container shall be legibly marked with the following information:

SCL purchase order number
