Streetlight Photocontrols, Button Type, Flush-Mount



1. Scope

This standard covers the requirements for flush-mount, button type, streetlight photocontrols.

This standard applies to Seattle City Light (SCL) Stock No. 569336.

2. Application

Streetlight photocontrols are used as light-sensing switches to control luminaries. Photocontrols are designed to switch lamps off during the day and switch lamps on at night.

Streetlight photocontrols are intended for use with High Pressure Sodium (HPS) residential streetlight luminaires. Photocontrols are also capable of switching High Intensity Discharge (HID), fluorescent, and incandescent lamps.


