1. Scope

This standard covers the requirements for 1.63 metric ton working load limit (WLL), swivel hook assemblies and replacement parts.

Spools are also known as thimbles.

This standard applies to the following Seattle City Light (SCL) stock numbers:

2. Application

Swivel hook assemblies are intended to be attached to rope soft eyes.

Swivel hook assemblies extend the life of rope soft eyes by keeping the rope positioned correctly on spool, providing a wider bearing surface resulting in an increased area for load distribution, and reducing abrasion.

Swivel hook spools are designed for synthetic rope sizes 9/16 to 5/8 inch.

Swivel hooks shall meet the applicable requirements of the latest revision of the following industry standard:

ASME B30.10; Hooks - Safety Standard for Cableways, Cranes, Derricks, Hoists, Hooks, Jacks, and Slings

Requirements

4.1 **Assemblies**

Assemblies shall be composed of a swivel hook, a shield, and a spool as described in Sections 4.2, 4.3, and 4.4.

4.2 **Swivel Hook**

Swivel hooks:

- Shall include a latch
- Shall be forged alloy steel
- Have a working load limit (WLL) of 1.63 metric tons
- Can be proof tested two times the WLL

WLL shall be based on a 5:1 safety factor.

WLL shall be stamped on each side.

4.3 **Shields**

Shields shall be:

- Nylon
- Red

Spools

Spools shall be:

- Nylon
- Designed for synthetic rope sizes 9/16 to 5/8 inch

4.5 **Latch Kits**

Latch kits shall be composed of the following:

- Latch
- High cycle, long life spring
- Cotter pin
- Through bolt
- Nut
