2. Application

Connectors are used to create an irreversible connection between conductor to conductor or conductor to ground rod in substation ground grids.

Connectors are installed with a common ratchet or socket wrench. When the connection is tightened to the proper torque, the bolt head shears off, giving a positive visual indication of a completed connection.

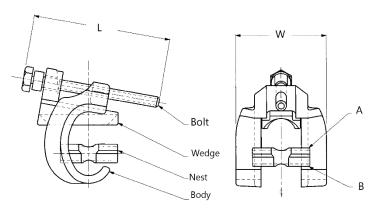
4. Requirements

- Product description
- SCL stock number

Each shipping container shall be legibly marked with the following information:

SCL purchase order number
