# **Conduit Bodies, Nonmetallic**



### 1. Scope

This standard covers the requirements for nonmetallic conduit bodies.

For metallic conduit bodies, see SCL 7050.17.

This standard applies to Seattle City Light (SCL) Stock No. 732613.

## 2. Application

Conduit bodies are used with Schedule 40 and 80 polyvinyl chloride (PVC) conduit to construct raceway systems for branch circuits. They serve as junctions for branch circuits and provide an access point for pulling, splicing, and maintenance.

Conduit bodies shall meet the applicable requirements of the latest revision of the following industry standards:



- Non-threaded hubs
- Textured cover with screws
- Foam-in-place or rubber gasket
- Gray color
- Type LR
