Nails, Brads, and Spikes



1. Scope

This standard covers the requirements for steel nails, brads, and spikes.

This standard applies to the Seattle City Light (SCL) stock numbers cited in Section 4.

2. Application

Common nail: As the name suggests, these are your everyday nails. Used for rough construction work, the common nail can be purchased in lengths varying from one to six inches (2d to 60d). The largest common nails are colloquially known as spikes.

Brads: Brads are essentially small finishing nails, proportionately smaller in diameter and length (one inch or less). They are used in making frames, attaching plywood paneling, and in cabinet-work.

Duplex nail: A variation of the common nail, the duplex nail features a second head, or "collar," located a short distance down the shaft from the first head. This design prevents the nail from being driven flush, making it easy to remove. It is used for temporary construction (like scaffolding and staging). Duplex nails are also known as double-headed nails.

4. Requirements

Nails, brads, and spikes shall be steel.

Nails, brads, and spikes shall meet the requirements of Table 4.

Stock No. 782286 shall be packaged 2-3/4 oz per package.

- Product description
- SCL stock number

Shipping containers shall be legibly marked with:

SCL purchase order number
