

## First Aid Supplies, Supplemental



### 1. Scope

This standard covers the requirements for first aid supplies, such as bandages, eyewash, fire blankets, hot and cold packs, sunscreen, and towelettes.

This standard applies to the Seattle City Light (SCL) stock numbers cited in Sections 5.

The first aid supplies cited in this standard are supplemental items not included in general use and trauma first aid kits.

General use first aid kits and replenishment supplies are specified in material standard 4018.15.

Trauma first aid kits and replenishment supplies are specified in material standard 4018.29.

First aid kit cabinets installed on walls of facilities are stocked by third-party contractors. Contact Safety Health and Wellness (SHaW) for restocking requests.

### 2. Application

Supplies specified in this standard are intended to supplement, on an as-needed basis, the contents of general use and trauma first aid kits, SCL material standards 4018.15 and 4018.29, respectively.

Product shall be packaged to prevent damage during shipping, handling, and storage.

Each standard package shall be legibly marked with the following information:

- Manufacturer identification
- Product description
- SCL stock number
- Quantity

Each shipping container shall be legibly marked with the following information:

- SCL purchase order number
