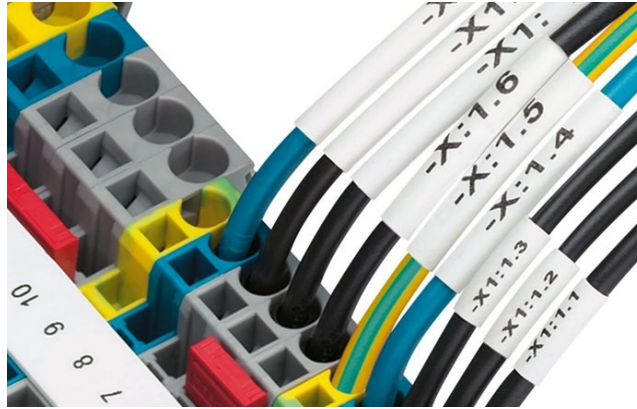


Labels, Printable Shrink Sleeve, Thermomark Printing System



1. Scope

This standard covers the requirements for printable shrink sleeve labels used with Phoenix Contact Thermomark Roll 2.0 printers.

This standard applies to the following Seattle City Light (SCL) stock numbers:

014933	Shrink Sleeve Label, 2.1 mm to 6.4 mm Cable Diameter
014934	Shrink Sleeve Label, 4.2 mm to 12.7 mm Cable Diameter
014935	Shrink Sleeve Label, 8.5 mm to 25.4 mm Cable Diameter

2. Application

Shrink sleeve printable labels are used to mark cables in substations.

Thermomark Roll 2.0 printers are used to print on the shrink sleeves.

3.1 Shrink Sleeve Label, 2.1 mm to 6.4 mm Cable Diameter

Manufacturer	Phoenix Contact
Part No.	0800322
Color	white
Width	10 mm
Length	100 m
Material	Polyolefine
Cable Dia.	2.1 mm to 6.4 mm
Mounting	Slide-on
Storage Condition	23°C/50% relative humidity, store in a dry and dark place in the original packaging
